Helen Williams and Andy Gutzwiller, North Park Ave. residents came before council and presented a petition signed by many residents living near the Community Mental Health Clinic at Park Ave. and Boehringer St. noting the following concerns.

- This is a residential single or duplex area of housing and they wish for it to remain as such.
- The existing multi-resident buildings located in the area are more than enough
- The existing units are not properly supervised causing those living in the area to feel unsafe in their own homes.

Beth Meyers made a motion, seconded by Darrick Cox, to formally adopt Ordinance # 10-2012; adopting the base rate for PERF for a 1<sup>st</sup> Class Police Officer. All ayes so passed.

Darrick Cox made a motion, seconded by Kevin Chaffee, to formally adopt Ordinance # 11-2012; 2013 salary ordinance for salaried and hourly employees. All ayes so passed.

Robert Narwold made a motion, seconded by Beth Meyers, to formally adopt Ordinance # 12-2012; 2013 elected officials salary ordinance. All ayes so passed.

Ann Edwards, representing Lifetime Resources, came before council with a 2013 Lifetime Resources Funding Request in the amount of \$10,000.00. The council will take the request under advisement.

Kevin Chaffee made a motion, seconded by Gene Lambert, to allocate \$2500.00 from Belterra Funds for the 2012 Apple Fest per the Batesville Kiwanis Club. All ayes so passed.

Gene Lambert made a motion, seconded by Robert Narwold, to allocate \$20,000.00 from Belterra Funds for the paving of the loop in the Brum Woods Trails Project.
